GENERAL INFORMATION

Standard Humic SG is formulated with potassium hydroxide and humic acids from leonardite, in a granule form, which is used as a soil improvement aid in all agricultural crops. When used in accordance with Directions for Use, Standard Humic SG may improve soil structure and aid in nutrient availability & micronutrient uptake.

DIRECTIONS FOR USE

Standard Humic SG is intended for dry applications only. Granules dissolve slowly and are not suitable for mixing with water for liquid applications.

Fertilizer Blending: Standard Humic SG is compatible for blending with dry fertilizers, including urea, MAP, DAP, KCL, SOP, and AMS. Always conduct a small-scale test to confirm compatibility before blending. For blends containing urea, include Standard Humic SG at a maximum of 10% of total blend and avoid storing for longer than 48 hours or in relative humidity > 70%.

SUGGESTED APPLICATIONS

Band Applications: In annual crops, apply 5 – 10 lbs / acre at or prior to planting in furrows, beds or fertilizer bands.

Broadcast Applications: In annual and perennial crops, broadcast 10 – 40 lbs / acre prior to planting (annuals) or prior to bud emergence (perennials). In perennial crops, subsequent applications may be made mid-season or at fall root flush, to a maximum of 70 lbs / acre per season.
